3. Introduction of the executive officer system

(1) Purpose of introducing the executive officer system

The introduction of the executive officer system is designed to clarify the responsibilities for the execution of operations, and increase the efficiency of management by strengthening the supervisory function and accelerating the decision-making process of the board of directors, by separating the functions of the decision-making process and the supervision, and the execution of operations.

(2) Summary of the executive officer system

- (i) The board of directors will determine the appointment, termination, duties, and responsibilities of executive officers.
- (ii) Directors may concurrently serve as executive officers.
- (iii) The term of office of executive officers will be two years, and reappointment will not be prohibited.
